Assumption of the Risk, Release and Waiver of Liability, and Indemnity Agreement Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Ka Hale O Na Keiki Preschool (KHONK) has put in place preventative measures to reduce the spread of COVID-19 per the Department of Human Services Guidelines and with the help of the CDC. However, KHONK cannot guarantee that you or your child(ren) will not become infected with COVID-19.

Further, attending KHONK could increase your risk and your child(ren)'s risk of contracting COVID-19. By signing this Agreement, I/we acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren), family and I may be exposed to or infected by COVID-19 by attending KHONK and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I/we understand that the risk of becoming exposed to or infected by COVID-19 at KHONK may result from the actions, omissions, or negligence of myself and others, including, but not limited to, KHONK employees, volunteers, and program participants and their families. I/we voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my/our child(ren) or myself/ourselves (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I/we or my/our child(ren) may experience or incur in connection with my/our child(ren)'s attendance at KHONK.

On my/our behalf, and on behalf of my/our children, I/we hereby release, covenant, not to sue, discharge, and hold KHONK, its employees, agents, directors, officers, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I/we understand and agree that this release includes any Claims based on the actions, omissions, or negligence of KHONK, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any KHONK operations.
